Brenda stated that Corrine had called her and asked that an appointment be set to go over the duties that are required of the secretary to be sure that Valarie will be able to work it into her schedule. Brenda will set the appointment and will ask Corrine if she wishes to sit in on it.

There being no other business to come before the Board, the meeting was adjourned at 5:45 pm.

## ADDENDUM TO MINUTES

By e-mail notice to all Board members, Lorrie moved that we remove the following language from the application form: \$10.00 after Sept 30<sup>th</sup> for initial membership only. By eliminating this language we will no longer pro rate dues for joining late in the year. It has caused a problem for the membership Director because some members think that if they renew after September 30<sup>th</sup> they only need to pay \$10.00 and this results in Lorrie having to contact them to collect another \$10.00 or return their check because they decide to wait until January to renew and get the benefit of an entire year for their \$20.00. By electronic vote this motion carried 4-1 with Art Molina not voting.

Lorrie also moved that the price of the name tags be increased from \$5.00 to \$6.00 because we have been paying \$5.70 for each name badge for the past year or two and the club has been picking up the difference. By electronic vote this motion carried 4-1 with Art Molina not voting.

Brenda will make these changes on the 2010 application which will be available December 1, 2009.
